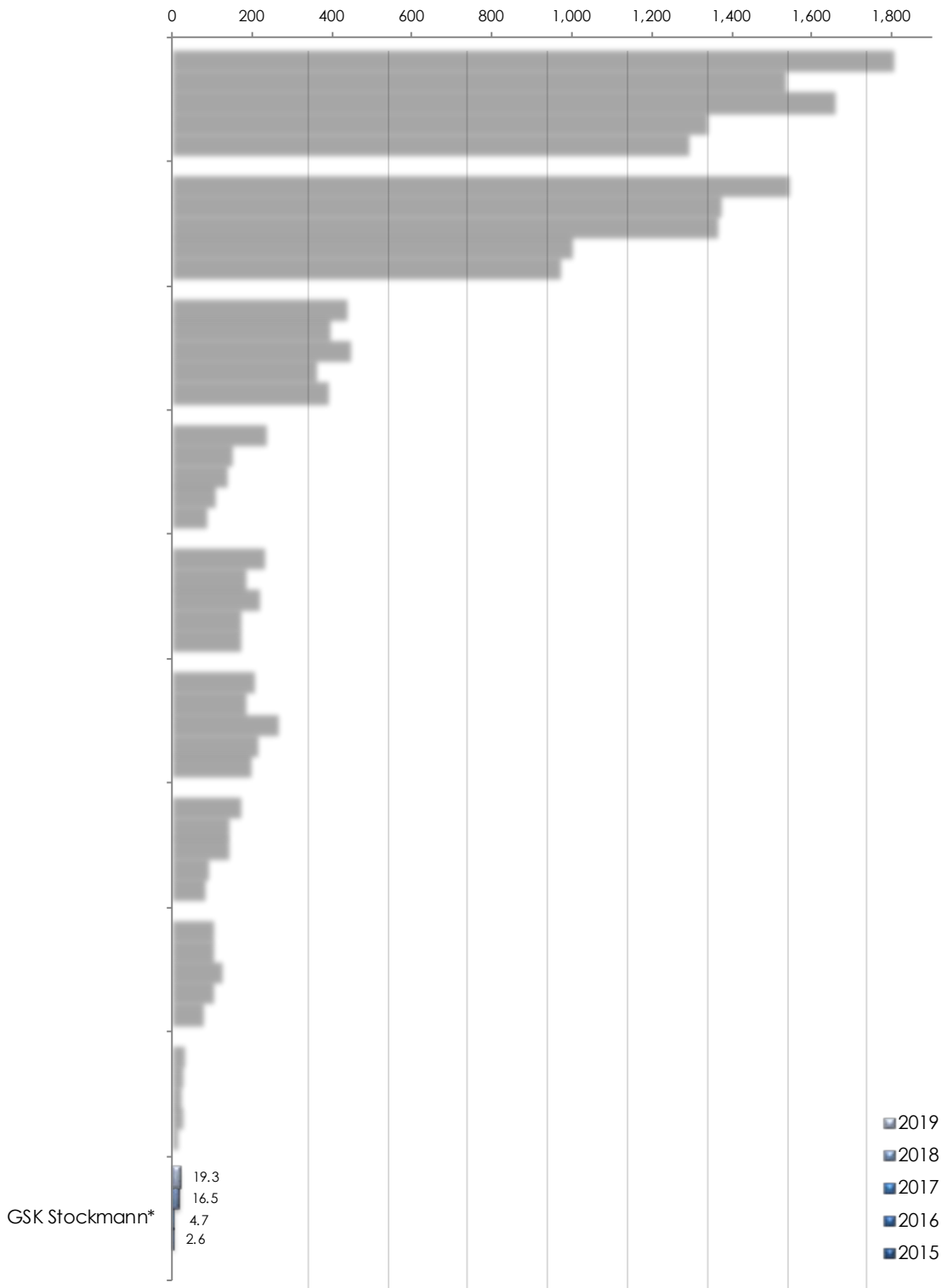
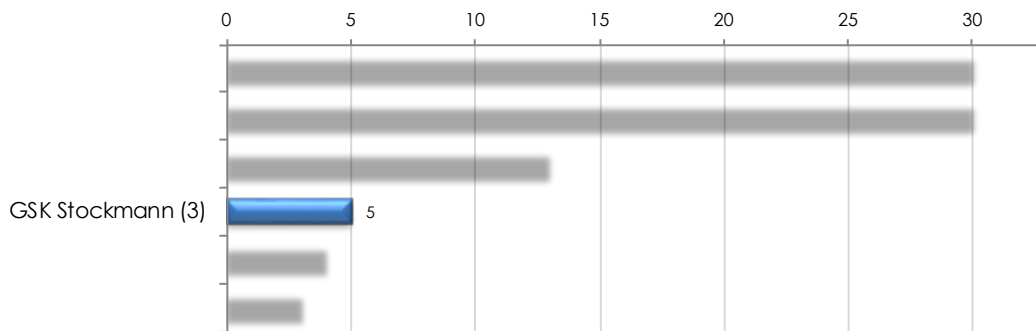

1.13.1 Largest Legal Advisers by Assets in US\$ billion



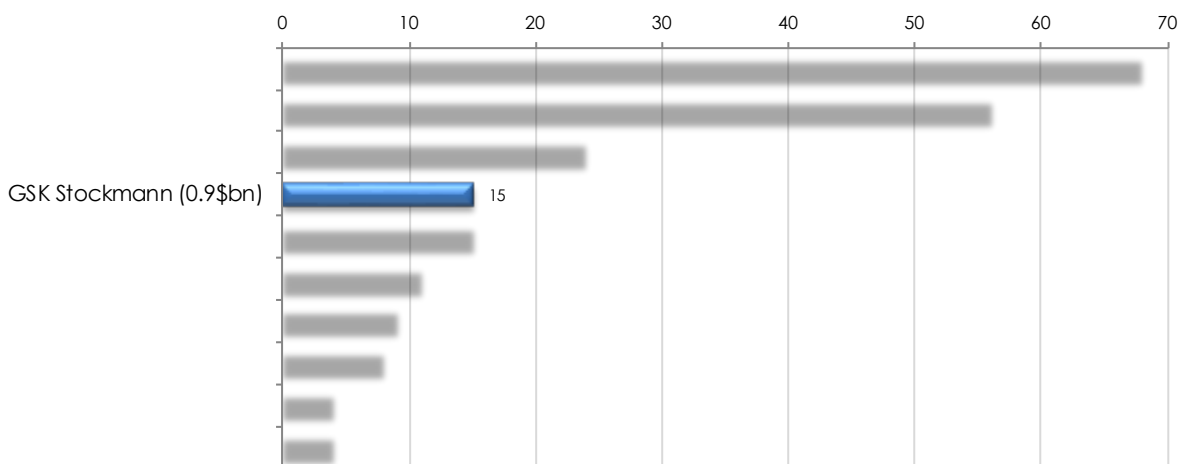
